

WAIVER OF LIABILITY AND ASSUMPTION OF RISK

I, _____, (**print full legal name**) understand that events are being hosted by _____ (“Host”) at the property located at _____ (“premises”), which premises are owned by _____ (“Owner”). I hereby acknowledge as follows:

1. **Voluntary Participation.** I acknowledge that I am freely and voluntarily entering onto the premises for the purposes of attending and participating in activities that are adult oriented in nature. I have not been forced or coerced to attend any event, and I understand that I am free to leave at any time.
2. **Adult.** I am at least 18 years of age.
3. **Activities.** I understand that the activities taking place at the premises are adult oriented and sexually explicit in nature, and may include, but are not limited to flogging; fire cupping; needle play; acts of domination and submission; bondage; discipline; spanking; paddling; sadism and masochism; oral, vaginal, or anal penetration; and other explicit and/or extreme sexual fetishes.
4. **Assumption of Risk.** I am aware that these activities involve certain risks and dangers, including physical harm, bodily injury, exposure to blood and blood-borne pathogens, transmission of sexually transmitted disease, or death. I participate in such activities with a complete understanding of the risk they pose to my person and/or property and voluntarily assume such risk. **PLEASE INITIAL** _____
5. **Liability Release.** In exchange for entrance to the premises, I hereby agree that I will not make a claim against nor sue the Host, the Owner, their heirs, agents, successors, assigns, or personal representatives, and that such release of liability is binding on my heirs, agents, successors, assigns, or personal representatives. Accordingly, I hereby release, waive, and forever discharge the Host and the Owner and their heirs, agents, successors, assigns, or personal representatives from any and all claims, demands, actions, or rights of action, of whatever kind or nature, arising from or by reason of my attendance at or participation in the event or activities. **PLEASE INITIAL** _____
6. **Indemnification and Hold Harmless.** I further indemnify and hold harmless Host and Owner, and their heirs, agents, successors, assigns, or personal representatives, from any and all claims, demands, actions or rights of action, of whatever kind or nature, either in law or in equity, arising from, or by reason of, my attendance at, or participation in, an event or activities for loss, liability, injury, damage, or cost that occurs due to my presence or actions at an event, whether intentional or negligent. **PLEASE INITIAL** _____
7. **Rules of the Event.** I agree to abide by all rules established by the Host, including specifically:
 - a. **Consumption of Intoxicants.** Intoxicants, including alcohol or marijuana, or any other drug, narcotic, or substance that is controlled under federal or state law, is expressly prohibited.
 - b. **Consent.** All contact between participants at an event must be consensual at all times. I agree that I will not touch or otherwise engage in any activity unless invited to do so, and that if said consent to touch or participate in an activity is withdrawn by the other participant(s), that I will immediately cease to participate. I understand that I have the responsibility to express whether I consent to touching or contact from other participants and agree to communicate the same to them.
 - c. **Recording.** I agree not to photograph or take sound and/or video recordings of any activities at an event *unless expressly permitted by the other participants*.
 - d. **Prohibited Conduct.** There shall be no prostitution, solicitation, or compensation for the activities performed on the premises.
8. **Acknowledgment.** I have reviewed this document and understand its contents. I am aware that this is a release of liability and a contract between me, Host, and Owner, and that I am waiving certain legal rights I might otherwise have. I am signing this agreement voluntarily, and I understand that this release shall be effective for one year from the date first signed below.
